It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **PROPOSED CONSTRUCTION OF MOROGORO CENTRAL MARKET ON PLOT NO. 180, BLOCK 'S' ALONG MADARAKA AND UHURU STREET**.
2. The **MOROGORO MUNICIPAL COUNCIL** now invites sealed Tenders from eligible contractors glistered or capable of being registered in **Class I** for carrying out the **CONSTRUCTION OF MOROGORO CENTRAL**

MARKET ON PLOT NO 180, BLOCK 'S' ALONG MADARAKA AND UHURU STREET.

Tendering will be conducted through the National Tendering policies and procedures laid down in the Public Procurement Act No. 7 of 2011 (hereinafter called PPA 2011) and the Public Procurement Regulations, 2013 – Government Notice No. 446.

All Tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes marked **PROPOSED CONSTRUCTION OF MOROGORO CENTRAL MARKET ON PLOT NO. 180, BLOCK 'S' ALONG MADARAKA AND UHURU STREET**, must be delivered to **the secretary of the Tender Board of Morogoro Municipal Council building**, at or before **10.00 am 5th April 2018 on Thursday**.

7. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **Morogoro Municipal Council Conference Hall, Morogoro Municipality.**
