1. This Invitation for Bids follows the General Procurement Notice for this Project which appeared in Development Business, issue no. WB320-969/07 dated August 2007.
2. The Morogoro Municipal Council has received fund from Development Partners and the Government of United Republic of Tanzania towards implementation of Water Sector Development Programme (WSDP) and intends to apply portion of the funds to eligible payments under the contract for Construction of gravity water supply schemes at Mindu Ward in Morogoro Municipal Council.
3. The Morogoro Municipal Council now invites sealed bids from eligible Civil Works Contractors for Construction of Water Supply piped schemes for Mindu, Madaganya, Mikoroshini and Mkwajuni Hamlets.

All bids in one original plus two copies, properly filled in, and enclosed in plain envelopes, the outer cover shall be clearly marked: **TENDER FOR (Construction of gravity Water Supply Schemes at Mindu Ward in Morogoro Municipal Council) LGA/079/2018-19/HQ/W/05** shall be submitted at or before **28th February , 2019 at 12:00 hrs local time**. Late bids will be rejected. Bids will be opened promptly thereafter in public and in the presence of bidders' representatives who choose to attend in person at the **Council Hall –Morogoro Municipal Council**
